- * FL Public Records Act: F.S. § 119.01 et seq.
- * Response: "Reasonable time" -- no fixed deadline (but 10-30 days customary)
- * Exempt records: Active criminal intelligence/investigation (§ 119.071(2)(c))
- * Enforcement: Writ of mandamus or attorney's fees under § 119.12
